### II. Fraternity & Sorority Community Updates

a. Definition of fraternities and sororities. StuAct representatives met with TAMU Title IX coordinator and general counsel to discuss an article entitled *Redefining fraternity: Examining title IX, the first amendment & private fraternal organizations.* This brought up a 1989 DOE memo that provided clarifiers for social versus professional/service/honorary organizations:

(1) Is the organization's membership limited to persons pursuing or having interest in a particular field of study, profession, or academic discipline?

(2) Is the membership limited to individuals who have a high level of achievement in scholarship or any other endeavor?

(3) Are the members permitted to hold membership in other fraternities or sororities at the same level of education?

#### c. IFC created a taskforce that is focusing on four initiatives

#### III. Subcommittee Updates & Discussion

### a. Finances & Staffing update included:

- i. Discussed terminology around fees vs. charge vs. dues
- ii. For the annual budget process (SAFAB), Student Activities requested an SDS III position IFC advisor. This was approved by SAFAB 5:4. This is the first step in the budget approval process
- iii. Recognition that what we have (resources) vs. expectations is not aligned
- b. Law, Policy, & Governance
  - i. Focused on initiative 17 new and returning organizations. Looked at documentation that already exists
  - ii. Led to conversations about definition of fraternity/sorority, council membership (which organizations are a part of councils and which are not, and why)
  - iii. Initiative 15 looking at implications of changing new member periods, pros/cons, purpose of process, how does this impact non-Greek organizations

### c. Education & Training

- i. Reviewed some of the existing documentation and training
- ii. Looked at initiatives 6, 7, and 8 how do we capitalize on the good work already being done?
- iii. Introduced the idea of sending out a survey to chapter presidents in January
- iv. How do you communicate requirements and how do you deliver content?
- v. FSL Experience Survey is currently being administered through 11/19
- d. Marketing & Communications (internal committee)
  - i. Website is continually updated
  - ii. Christine and Shanté are hosting a webinar with HQ on Thursday, November 8 to provide updates and seek feedback
